RELEASE OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

PLEASE READ CAREFULLY BEFORE SIGNING. THIS IS A RELEASE OF LIABILITY AND WAIVER OF CERTAIN LEGAL RIGHTS.

As a condition of the season pass and as part of the consideration for issuing the season pass, **I voluntarily agree to expressly assume any and all risk of personal injury, death or property loss** resulting from any cause whatsoever including but not limited to the inherent risks of skiing, the use of ski lifts, collisions with natural or manmade objects or other skiers, travel within or beyond the ski area boundaries or negligence on the part of the ski area operator and/or its employees. The season pass holder agrees that Shanty Creek and its employees shall not be liable for any such personal injury, death or property loss and **releases** Shanty Creek, its employees and agents and waives any and all claims with respect thereto.

I further agree to hold harmless and indemnify Shanty Creek from any and all liability for any damage to property or personal injury to any other part resulting from my use or presence on the facilities.

This agreement shall be governed by the applicable law of the State of Michigan. If any provision of this agreement is determined to be unenforceable, all other provisions shall be given full force and effect.

By using the pass(es), I hereby give permission to Shanty Creek to use my image and photographic likeness in all forms and media for advertising, trade and any other lawful purposes. This includes any and all images taken during this season of me, without further compensation to me. All film or digital files shall constitute the sole property of Shanty Creek.
