I understand that season passes are non-transferable and non-refundable. I understand that legal action will be taken against HOLDERS found to be using season passes fraudulently. I understand, that without Creek Care insurance, a \$30 fee will be charged to reissue a lost or stolen pass and that if I forget my Savings pass, I will be charged the lift ticket rate to receive skiing privileges
